## DEED OF GIFT

The undersigned transfers and assigns literary and copyrights\* of the materials described above to the GHS, to the extent applicable, with the protection afforded by law under Federal copyright laws and Title 17 of the United States Code. GHS, as owner of these rights transferred by this Deed of Gift, may exercise or transfer to a third party the right of quotation or publication.

*\*Excludes third party copyright and publications in this donation by a living donor bearing a notice of copyright.*

GHS shall have the right to decline any items included in the donation that are duplicated elsewhere in the GHS library and archival collections or which are deemed by GHS professional staff to be inappropriate for inclusion based on our collection development policy or condition of materials.

In the event that all or part of your donation is not accepted:

- I would like to be notified and given the opportunity to reclaim the item(s) in person or have them mailed to me at my expense.
- I give GHS permission to redistribute or dispose of my donated items based on professional standards.

After the donation is processed, GHS shall have the right, at any time, to reproduce and/or reformat the materials contained in the original collection for preservation, publication and distribution. Collections take time to process and may not be available for immediate use by researchers in hard copy or electronic format. Donations of materials accompanied by a charitable contribution will receive priority processing.
